HIV/AIDS: FACT OR FICTION

African Americans are one of the leading groups affect by HIV in this country.

FACT: While African Americans make up just 13% of the US population, the group accounted for 50% or more of new HIV diagnoses in 2004.

As many of you may know, last November, the Frannie Peabody Center, in conjunction with the City of Portland, received a new grant from the U.S. Dept. of Housing and Urban Development (HUD). Our grant came from a sub division of HUD called Housing Opportunities for People with AIDS (HOPWA). HOPWA is the only federal housing program dedicated to the needs of people living with HIV/AIDS and their families.

Approximately 90% of HOPWA funds are allocated by formula to states and metropolitan areas with the highest number of cases and incidence of AIDS.

The remaining 10% are awarded through competitive grants aimed at providing permanent supportive housing.

Maine does not receive formula HOPWA funds. Frannie Peabody Center is the grantee for the state's first two competitive HOPWA grants. The City of Portland is the grantee for the most recent competitive HOPWA grant.

In the program year 2005-2006, FPC's second grant, HAVEN II, which focuses on providing housing assistance and supportive services to low-income people living with HIV/AIDS in the City of Portland and Cumberland County, saw that nearly half (48%) of clients served were of racial and ethnic minorities.

The minority population in the City of Portland has almost tripled in the last decade, due largely to an influx of immigrants and refugees. One of the most critical needs identified by those working with this emerging population is housing. That is why the third HOPWA grant awarded to the city will focus on outreach to racial and ethnic minorities.

HOW IT AFFECTS YOU?

Through our partnership with HUD, we at FPC are able to offer focus groups put on by AIDS Housing Corporation (AHC) out of Boston. AHC is looking for anywhere from 5-12 clients to attend each group. This will be a time for consumers to share

their ideas and thoughts about services they need or have used to achieve and maintain stability. Each focus group will last approximately 2.5 hours (Dinner will be included). Questions are asked to determine the type of resources being used, barriers people face, their knowledge of living with HIV/AIDS and what needs are not being met. There are two groups scheduled, one in York County, Tues. Feb. 27th at 5pm, and one in Portland on Thurs. March 1st at 5pm. These groups are open to all clients currently receiving services from FPC (both housing and case management). We at FPC feel that it is extremely important to continue to keep up with the needs of our clients, as the management of HIV changes as well as the populations affected. Also, we encourage anyone who is available to attend these focus groups. Your input is important to our future programming! RECOMMENDATIONS FOR LEGISLATION

The Maine HIV Advisory Committee will present recommendations to DHHS and support legislation that would increase access to testing, increase access to needle exchange programs, and increase funding to HIV treatment, care, and research.

As it stands now, the bill for increase access to testing supports routine, streamlined HIV testing in all health care setting. Also, this bill would drop the

requirements for all pre-test counseling and post-test counseling for a negative results. In addition, the requirement for specific written consent would be dropped, however verbal consent would be required. This won't impact anonymous testing.

In brief, the needle exchange bill would eliminate the limit on the number of syringes that can be distributed. And the funding

bill would devote appropriate amounts to care, prevention, and studies that would shape future programming.

AIDS GROUP TO SUE PFIZER OVER VIAGRA ADS

AIDS Healthcare Foundation (AHF) on Monday filed a lawsuit against Pfizer Inc. for allegedly promoting recreational use of its erectile dysfunction (ED) drug Viagra. The nonprofit treatment organization's suit claims Pfizer's actions have led to risky behavior by men and an increase in HIV and other STDs.

AHF cites Pfizer's Viagra Web site, which asks readers, "Want to improve your sex life?" and says the drug can help men who have difficulties attaining an erection "once in a while." The foundation's legal arguments point to Viagra's marketing materials from recent years, including an ad that ran around the 2006 Super Bowl that urged

men to "Be this Sunday's MVP" and talk to their doctors about Viagra.

Such promotions make Viagra sound like a "party drug," said AHF President Michael Weinstein. "The message they are sending out is that any and every male should take it," he said. In 2004, after a complaint from the Food and Drug Administration, Pfizer pulled a TV commercial in which a man sprouted devilish horns. The ad's suggestion that Viagra could restore a man to the "wild thing" of his younger days was an unproven claim, FDA said.

Studies have documented recreational Viagra use among men who have sex with men,

sometimes to alleviate the erection-inhibiting effects of alcohol and drugs like crystal meth, AHF noted.

The lawsuit asks that Pfizer be prohibited from running similar ads and ordered to fund awareness ads about STD risks and Viagra. It also requests that Pfizer use profits gained from the ads to pay AHF's costs for treating HIV and other STDs linked to Viagra use.

Pfizer spokesperson Shreya Prudlo said the company "has always been committed to safe and appropriate use of Viagra," and its label and promotions clearly state: "Viagra does not protect against [STDs], including HIV."

A dish to warm the heart!

Ingredients:

1 box Penne Pasta

1 large container of ricotta cheese

1 large jar of traditional pasta sauce

1 package (2-3 cups) of shredded sharp cheddar

2 tomatoes, chopped coarsely

1 casserole dish (8x11)

Aluminum foil

Preheat oven to 350'. Cook pasta according to directions on the box, drain, and mix the ricotta cheese while pasta is still warm. Spread a bit of pasta sauce on the bottom of the dish, add a layer of noodle mixture, covering bottom, spread a layer of sauce, and cheese. Repeat layers (no tomatoes) until you reach the top - about three layers on average.

Cover top with foil, be careful not to touch the cheese or you might lose a layer!

Bake covered for 45 minutes to an hour.
