In 2025, Frannie Peabody Center continued to lead through collaboration with partners across Maine to respond to the state's largest HIV outbreak in history. We provided technical assistance and direct support to public health partners in Bangor, helping strengthen local response efforts at a critical moment. In close coordination with the Maine CDC, community-based organizations, and local healthcare providers, we also expanded HIV testing and linkage efforts, ensuring more people could access timely services while reinforcing a coordinated, public health-driven response.

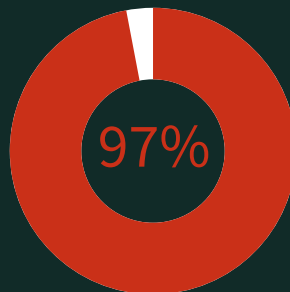

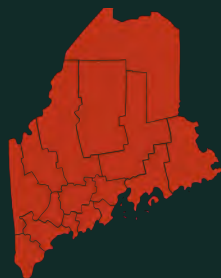
Prevention + Care
